In 1999 the Wisconsin Chiefs of Police Association made as one of its goals, the establishment of a Line-of-Duty Death Resource Committee to serve all law enforcement agencies in the state including not only municipal and sheriff's departments, but also Federal agencies such as the FBI and ATF, and State agencies as DCI, DNR, and the Wisconsin State Patrol.

The LEDR Team is trained to assist with all details including Critical Incident Debriefing, peer counseling, and funeral/memorial service preparation. Continued follow-up services and resources, in cooperation with organizations such as WI Concerns of Police Survivors and the Wisconsin Law Enforcement Memorial board, will be available to all departments.
